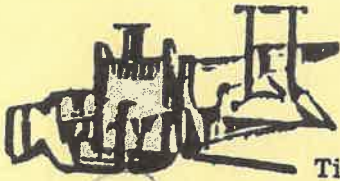

RECOMMENDATIONS:

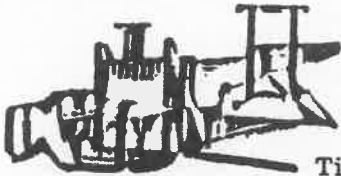
We plan to spend the balance of the budget after January 1st to benefit from greater discounts, and to continue our purchasing plans.
